

January 2012 CCVPD Highlights

Crime

1. Armed street robberies in upper NW and Friendship Hts area in the first 2 weeks of the month; they have slowed, but 2 occurred late in the month, and no arrests have been made
2. Multiple thefts (or attempted thefts) from auto (9); 1 stolen auto. All vehicles were unlocked.
3. Copper gutter thefts continue in the Bethesda area; only one in the Village to date (5600 block of Grove; unoccupied house under renovation)
4. Arrest warrant obtained for the All Saints Church thief; will re-publish story when he is arrested

Personnel

1. Made a final offer of employment to Mr. Franklyn Sanchez to fill our vacant police officer position; he has a B.A. in English from Georgetown University, is bilingual (Spanish/English), and was an NCAA athlete in cross country and track.
2. Dispatcher Beverly Perkins returned to her duties on 1/14 following knee replacement surgery
3. Officer Tan returned to full duty status on Wednesday, 1/18 following her rollover collision
4. **Integrity:** On Saturday, January 14, Jamie Timmerman found a \$1 bill on the ground near one of the speed cameras. No one else around. He logged it into the property/evidence room, wrote a report.
5. Sgt. Dasilva, Comm. Supervisor Lyerly, and Officer Chung completed NCIC recert training to maintain access to law enforcement databases
6. 7 compliments for 6 employees were received from residents and others who were served by CCVPD staff.

Administrative

1. Submitted proposed Police Department budget for FY13
2. Worked 2 overnight shifts with Officers Hearn and Hrnjak
3. Settled for \$13,300 for Stock 726 (rollover collision)
4. Met with security contractor/consultant to evaluate feasibility of new technology for the Village
5. Public Safety Committee meeting (1/24)
6. "All Hands" meeting (1/26); portraits and group photos taken by a MCPD photographer (no charge); policy changes; review of proposed FY13 budget and other matters; every PD employee was in attendance and it went well.
7. Our dispatchers are now able to monitor all Fire/Rescue calls that are dispatched to the fire 'beat' that includes Chevy Chase Village. If/when they hear a call go out, they quickly discern from the audible dispatch if the address is in the Village. If it is, they will immediately dispatch an officer. If it is not, they will reset the device and silence it.

Other

- POTUS visited 12 Primrose Street on Tuesday, January 31. CCVPD, with the help of the Public Works Department, established a temporary 'No Parking' zone on Primrose in advance of the event. All residents complied with the signage and we are grateful for that. CCVPD attended 2 planning sessions and assisted MCPD, MPDC and USSS in securing the area during the day on Tuesday, and throughout the evening before, during and after the visit.








Incident Frequency by DISTRICT (Top 4 of 4 Shown) (Using DATE RECD)
