Crime/Operational

- **Theft of package from front porch:** On 2/17 at 1:45 p.m., a package was delivered to the front porch of a house in the 200 block of Primrose Street. At 3:00 p.m., the homeowner went to retrieve the package, and it was gone. No suspect was seen.

Administrative

1. **New dispatcher hired:** On Wednesday, February 12, Mr. Timothy Wainscott began his 5-week training period as our newest Communications Clerk filling a vacancy that we had. He is progressing well and will complete his training later this month, and he will be assigned to the midnight shift.
2. **General Assembly testimony:** Chief Fitzgerald testified at the House Judiciary Committee and the Senate Judicial Proceedings Committee against HB599/SB436 which would create an exclusionary rule for administrative hearing boards related to police officer disciplinary matters.

Upcoming

- **Crisis intervention training:** In March, two more officers—Sgt. Tiedemann and Officer Hearn—will be attending this week-long course that will train officers how to better communicate with and de-escalate situations involving persons with disabilities, mentally or developmentally disabled individuals, and persons in emotional crises.





Chevy Chase Village Police Department Officer Hours for February 2014 within Chevy Chase Village




Incident Frequency by DISTRICT (Top 4 of 4 Shown) (Using DATE RECD)
