## Update on Capital and Utility Infrastructure Projects

### Village-wide Sidewalk Replacements

The Village's sidewalk contractor, Capital Hard-scapes, has been working to replace the sidewalks along Hesketh Street. Weather permitting the contractor anticipates that the replacements on Hesketh Street will be completed by the middle of February and continue onto Magnolia Parkway. During construction the contractor will ensure that pedestrian access is maintained on at least one side of the street at all times.

In response to questions residents have posed thus far during the project a list of "Frequently Asked Questions" has been developed and can be viewed by visiting the Village website. If you have a question that has not been addressed, please contact the Village office.

### WSSC Water Main Replacements

The Washington Suburban Sanitary Commission is continuing to replace, upgrade, and, in some cases, relocate two miles of water main lines throughout the Village. This phase of the project involves the relocation of water mains on portions of Cedar Parkway and all of Oliver Street.

Due to delays as a result of weather and construction material availability, WSSC contractors are running 1 month behind schedule. It is anticipated that work on Oliver Street and Cedar Parkway will be completed by the beginning of March. The next phase of this project will be determined once the crew completes its work on Cedar Parkway.

In an effort to provide timely and accurate information on the progress of the Sidewalk Replacement Project and the Water Main Replacement Project, dedicated pages have been created on the Village's website for these projects updates. he/she is a registered qualified voter in the State of Maryland and has lived in Chevy Chase Village for thirty days prior to the election. Board members serve two-year, staggered terms.

If the number of candidates equals the number of available seats, the candidates will be elected by acclamation at the Annual Meeting on Monday, April 16. If the number of candidates exceeds the number of available seats, a contested election will be held on Saturday, May 5.

The Village Elections Committee oversees Village elections, including receiving nominations to the Board of Managers. Nominations may also be made from the floor at the Annual Meeting (Wednesday, April 16, 2012).

## Budget Work Sessions

The Board of Managers will hold two budget work sessions to review the Village Manager’s draft budget for the fiscal year that will begin on July 1, 2012 and end on June 30, 2013.

- **Thursday, February 16 at 7:30 p.m.**
- **Monday, March 5 at 7:30 p.m.**

The work sessions are open to the public, although public comment will not be permitted until the public hearing on the budget in April.

While it is too early to tell if a consensus can be reached, there are some areas of general agreement—mainly centered on the public use space and the general arrangement of buildings on the site. Height and density continue to be unresolved issues.

The Village’s main concern centers on the issue of additional traffic that the development is certain to generate. Both Connecticut Avenue and Brookville Road will see increased traffic with added development, especially at the levels currently being discussed. The Land Company is conducting a traffic analysis which it will present to the communities this month. At the same time the planning staff at Park and Planning is conducting its own traffic studies. The traffic analysis will look at traffic on Connecticut Avenue as far south as Bradley Lane.

As the schedule now stands, the Park and Planning staff proposal for the rezoning of Chevy Chase Lake Sector will be presented to the Planning Board in late February or early March. A public hearing will be held by the Planning Board sometime in April with a final plan sent to the County Council in the summer. Representatives of the Village will continue to meet with the Chevy Chase Land Company, to work with our neighboring communities, and to weigh in where Village interests are affected. ## Call for Volunteers to Serve on the Elections Committee

Last year, the Village Board of Managers created a 5-person Elections Committee to assist in managing and overseeing elections to the Village's Board of Managers. The committee's members are appointed by the Chair of the Board of Managers to serve four year staggered terms.

The term of Elections Committee Member Mr. Irwin Pernick (Hesketh Street) ends this upcoming March. Mr. Pernick has indicated that he will seek reappointment. Committee members must:

- have resided in the corporate limits of Chevy Chase Village for at least one year
- be a registered voter in the State of Maryland
- be proficient in the use of email

## Board of Managers Meeting Board Actions—January 9, 2012

**Approval of Previous Meetings' Minutes:** December 12, 2011 Regular and Executive Sessions—approved. **Appeals:** . **A-5854—135 Grafton Street:** Install a stoop with three treads that would encroach five (5) feet forward of the front building restriction line—approved. **A-6061—5803 Kirkside Drive:** Install a fence, a pair of driveway gates and a walkway gate measuring a maximum height of fifty (50) inches in the Kirkside Drive public right-of-way—approved. **A-6063—20 Magnolia Parkway:** Install a handrail along an existing private walkway and stairs located in the Magnolia Parkway public right-of-way—approved. **A-6060—5815 Cedar Parkway:** Construct a fence measuring a maximum of six feet, three inches (6'-3") in height in the north (front) yard of private property, and in the West Irving Street public right-of-way—deferred. **A-6062—3 Newlands Street:** Install an above-grade water feature, which encroaches into the seven (7) foot rear yard setback—approved.

**New Business: Resolution No. 01-02-12:** A Resolution authorizing the designation of Chevy Chase Village as a sustainable community by the Maryland Department of Housing and Community Development and Application for such designation—approved.

## Bring Your Bag and Fight Litter

Starting January 1, 2012, all retail establishments in Montgomery County that sell goods and provide their customers a carryout bag (either paper or plastic) are required to charge 5 cents per bag.

- Montgomery County's new Carryout Bag Law is designed to improve our environment by cutting down plastic bags—a significant source of litter—which pollute our streets, streams, and playgrounds, and harm property values.
- A similar program has been in effect in Washington D.C. for the past 18 months and has already reduced plastic bag litter that clogs the rivers and streams in Washington D.C. by an estimated 65 percent.
- Proceeds from the Carryout Bag Law go exclusively to programs that fight litter and provide storm water pollution control in Montgomery County.
- Residents can avoid the charge for carryout bags by bringing their own bags to carry purchases out of the store.
- The 5 cent charge also applies to purchases made over the phone/internet/fax/or at self-checkout counters, if you use store provided carryout bags.
- Some bags are exempt from the carryout bag law. Examples include bags used to package bulk or perishable items, prescription drugs, as well as paper bags from restaurants and delis for customers to carry out prepared or leftover food.

## Village Snow Removal and Power Outage Procedures

The Chevy Chase Village Public Works crews plow the Village streets 24 hours a day, 7 days a week during storms with accumulative ice and/or snowfall. To support the efforts of the Public Works crew, Village residents are asked to, if possible, move their cars off of the street to their driveway to allow the crew to plow the streets. Please remember that no more than 48 hours following a storm, Village residents are responsible for clearing snow, sleet or freezing rain from abutting sidewalks in the public right-of-way, after which, Village Police can issue citations for violations. These range from a simple fine (\$50) to a lien against the property if Public Works is required to intervene to clear the property.

If your power does go out, please be sure to notify PEPCO directly at 1-(877) 737-2662 in addition to notifying the Village's 24-hour Communications Center at (301) 654-7300 so that the Communications staff can be aware of the outages throughout the Village.

If your power is out and you need to leave your home, please call the Communications Center to notify them of the best number to reach you in the case that PEPCO needs access to your property or to simply notify you that your power is back on.


## Reminder: Register to Vote for the Village Board AND National Election

- Your local Board of Elections;
- The State Board of Elections;
- The Motor Vehicle Administration;
- Offices on Aging;
- All public institutions of higher education;
- Recruitment offices of the U.S. Armed Forces;
- Offices for students with disabilities at all Maryland colleges

A voter registration application may be submitted to your local Board of Elections or the State Board of Elections at any time. However, an application must be postmarked by March 13, 2012, to vote in the Primary Election, to vote in the General Election.



## Ethics Commission Vacancy

The Ethics Commission is chartered by the Village's Public Ethics Code (PEC; a copy of which is available on the Village website) to serve as the advisory body responsible for:

1. Interpreting the Village's PEC,
2. Advising persons subject to the PEC as to its application,
3. Hearing and deciding on advice of Village Counsel, any complaint filed regarding an alleged violation of the PEC, and
4. **Hall** forms (such as the financial disclosure form required to be completed annually by each member of the Board of Managers) submitted in accordance with the PEC.

## Be a Responsible Pet Owner: Know and Follow the County Law

The Chevy Chase Village Police Department receives a variety of pet-related complaints. The county's animal control laws apply in the Village and are enforceable (via civil citation, generally) by our officers. By way of reminder, below is a list of selected animal control laws summarized from the County Code. Please review them and comply with them. Additionally, please share this information with all of your pet's caretakers. Being a good citizen includes being a responsible pet owner.

Violations of the County Code may be placed as civil offenses or criminal offenses. Unless otherwise noted, the penalty for the below offenses are:

<i>Civil Offense</i>	<i>Criminal Offense</i>
\$100 for a first offense	Maximum fine of \$200 and a maximum jail term of 30 days
\$150 for a subsequent offense	
\$500 for an offense occurring after receiving notice—in any form—of a violation	

**At Large Animal:** Any dog is at large if it is outside the owner's premises and not leashed unless it is in a dog exercise area designated by the Maryland-National Capital Park and Planning Commission or is participating in a qualified activity (hunting, obedience training, tracking, search and rescue). Wireless/remote leashes do not satisfy the "leash law".

**Animal Noise Disturbance:** An owner must not allow an animal to cause noise that is loud enough and persistent enough to disturb another person's quiet enjoyment.

**Animal Defecation ("pooper scooper" law):** An owner must not allow an animal to damage or defecate on property outside the owner's property. An animal may defecate on public property or the common area of property in which the owner shares an interest if the owner immediately removes and disposes of the feces by a sanitary method approved by the Director of the County's Animal Services Division. Feces may be picked up in a plastic bag. If this bag is placed inside another plastic bag, it may be put out for disposal in your normal household trash.

**Animal Trespass:** An owner must not allow an animal to enter private property without the property owner's permission

**Unwanted Contact:** Pet owners must prevent unwelcome or unsolicited threatening physical contact or close proximity to a person or a domestic animal that occurs outside the owner's property that may cause alarm in a reasonable person, such as biting, chasing, tracking, inhibiting movement, or jumping. **The civil penalty is \$500 for a first offense, \$750 for a subsequent offense. The criminal penalty is a maximum of a \$1,000 fine and 6 months in jail.**

## New Year's Resolution— Let's Curb our Carbon Footprint!

As we ring out the old year and ring in the new, it's worth taking a look at how we are doing globally on CO<sub>2</sub> emissions and what we can do as a community and as individual households to reduce our carbon footprint. The Carbon Dioxide Information Analysis Center at Oak Ridge National Laboratory, the US Department of Energy's primary center for data and analysis on climate change, estimates that in 2010, the latest year for which data have been assessed, global emissions reached a record high of 33.5 billion metric tons of CO<sub>2</sub>. This amounted to a 5.9% increase over global emissions from the previous year (2009), and a 49% increase since 1990, the year that the Kyoto Protocol established as a baseline to measure increases or decreases in CO<sub>2</sub> emissions by countries.
