

## February 2017 CCVPD Highlights

### I. Crime/Operational

1. **One theft from an unlocked car:** A jacket worth \$250 was taken from a car parked overnight in a resident's driveway on West Melrose Street.
2. **Two bicycles stolen:**
  - **5500 block of Grove Street:** A bicycle was taken from an enclosed rear porch; due to reporting rules, this was classified as a burglary.
  - **6300 block of Broad Branch Road:** A thief stole the resident's bicycle which had been left outside and unsecured; the thief abandoned a second bicycle in the resident's yard.

### II. Administrative

- Ms. Mary Gilligan, a Communications Clerk assigned to the night shift, resigned on February 16, and we immediately began to recruit to fill her position. We expect to select and train a new employee in the near future.
- On February 21, Chief Fitzgerald testified in support of identical bills in the Maryland House of Delegates (HB767) and Senate (SB970) that would change the public records law to protect individual privacy related to body camera recordings; votes are pending.

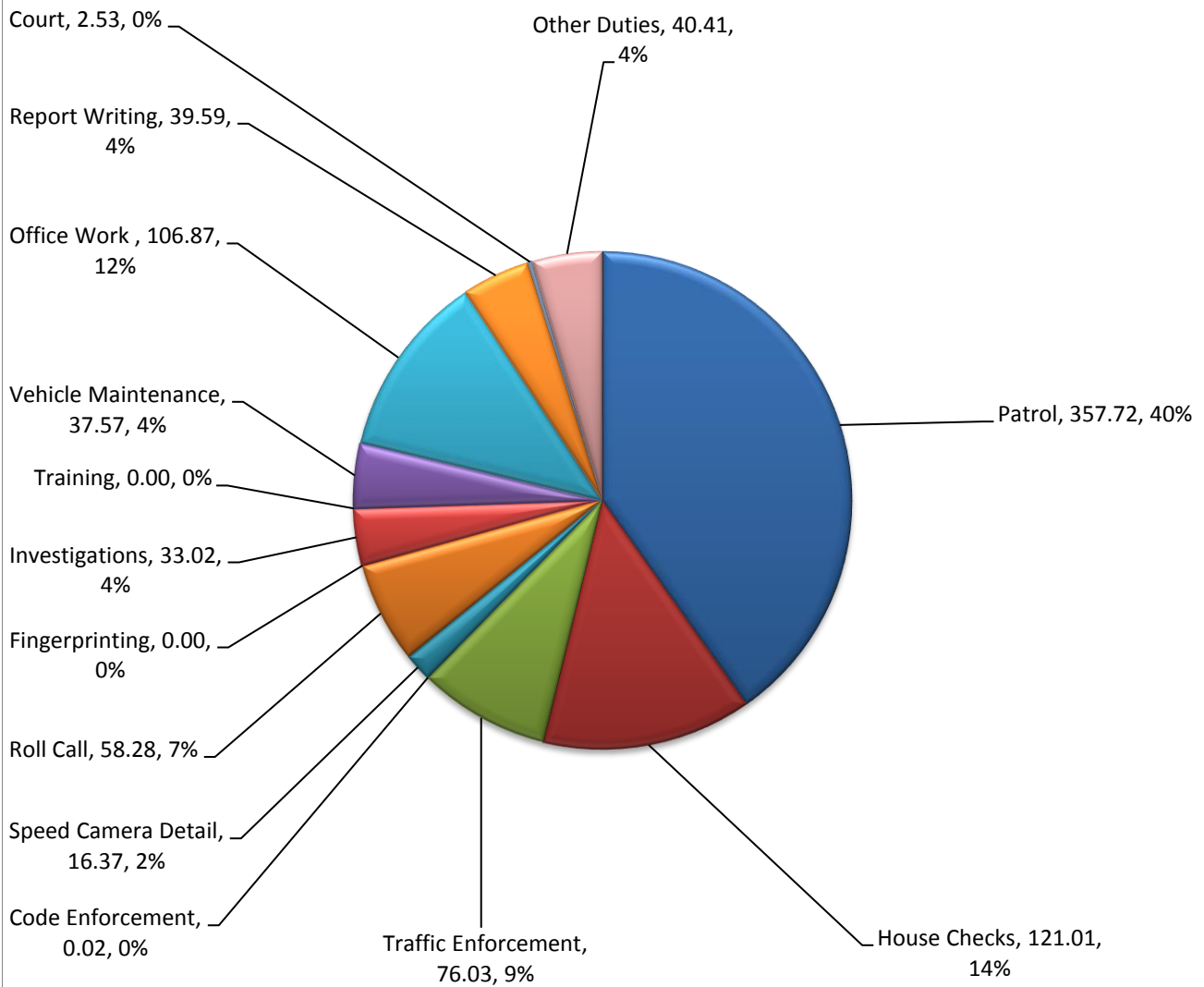

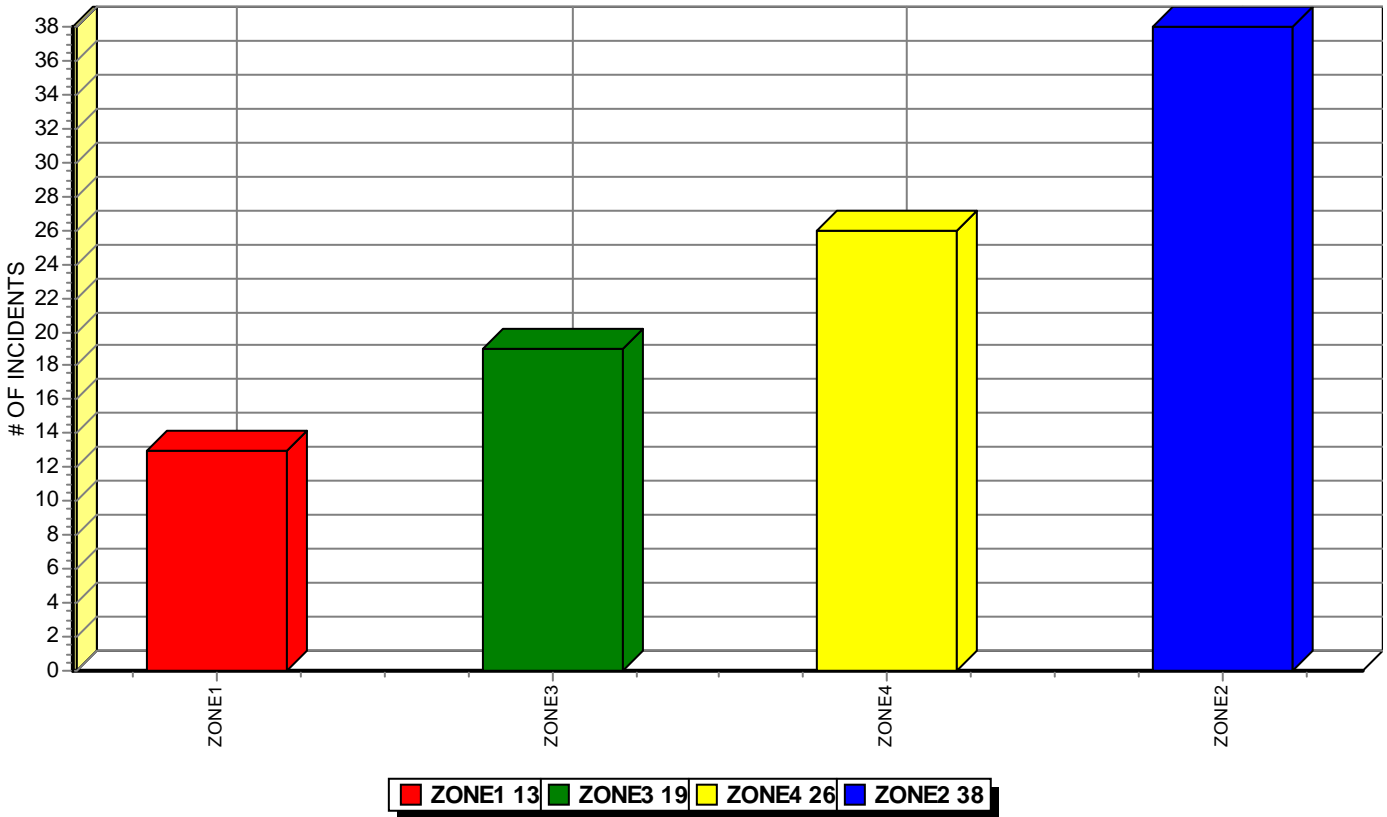

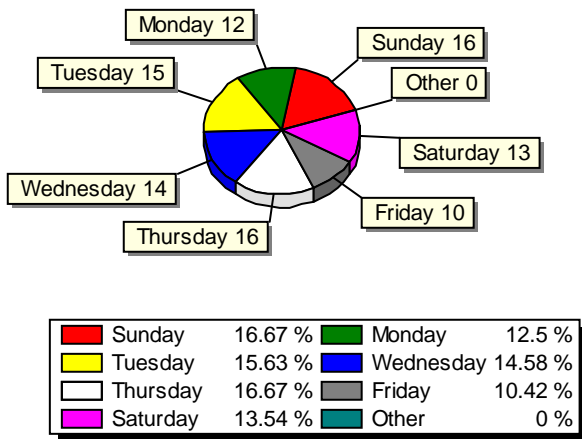

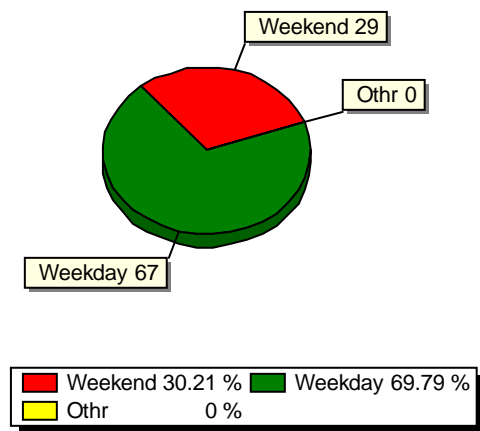
**Incident Frequency by DISTRICT (Top 4 of 4 Shown) (Using DATE RECD)**
