

March 2017 CCVPD Highlights

I. Crime/Operational

- **Five unlocked cars entered early in the morning (5:25 a.m.) on March 13:**
An alert resident called the police after seeing a young man entering 2 unlocked cars in a driveway in the 100 block of Primrose; the man was being shadowed by an accomplice in a silver or gray Honda CR-V. Investigation revealed that cars at 5 addresses were entered—4 on Primrose and 1 on Oxford. A Swiss Army knife and \$1.50 in coins were taken from one car; nothing was taken from any of the other cars.

II. Administrative

- On March 20, Ms. Dana Orth was hired as a full-time probationary Communications Clerk to fill the position vacated by Mary Gilligan’s resignation on February 16. Ms. Orth has 24 years of experience with Montgomery County’s 9-1-1 center, and she will be assigned to the overnight shift when she completes her training.
- The bills related to body camera recordings (HB767/SB970) passed in the full House of Delegates 133-3, but it failed in the Senate Judicial Proceedings Committee, so we’ll have to wait another year. We will work with the lobbyist for the Chiefs and Sheriffs to determine why it failed in the Senate so that we can improve our chances next session.
- All officers have transitioned to the newly-purchased duty handguns and the Chief is overseeing the disposition of the surplus handguns pursuant to the Village Code.

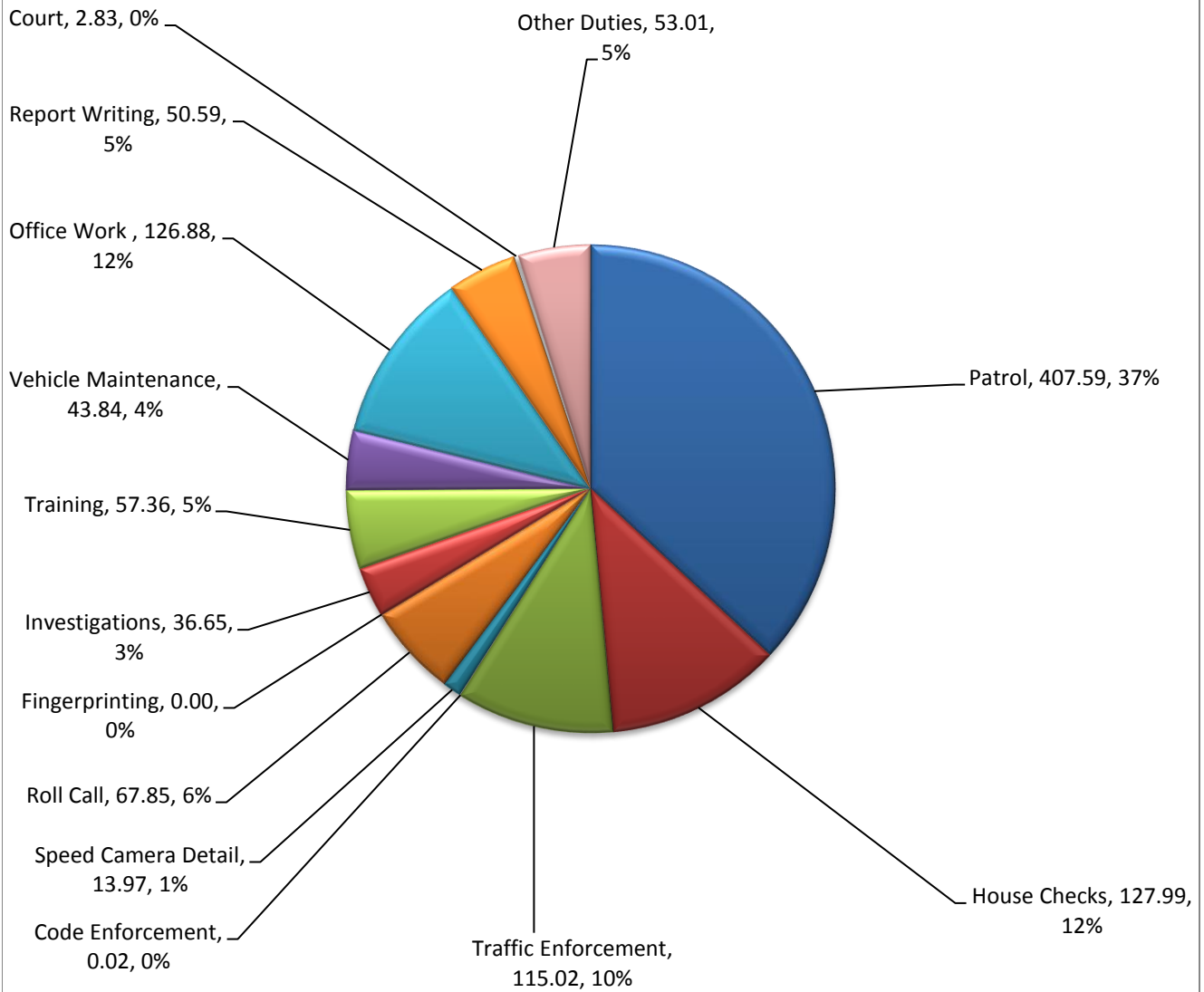

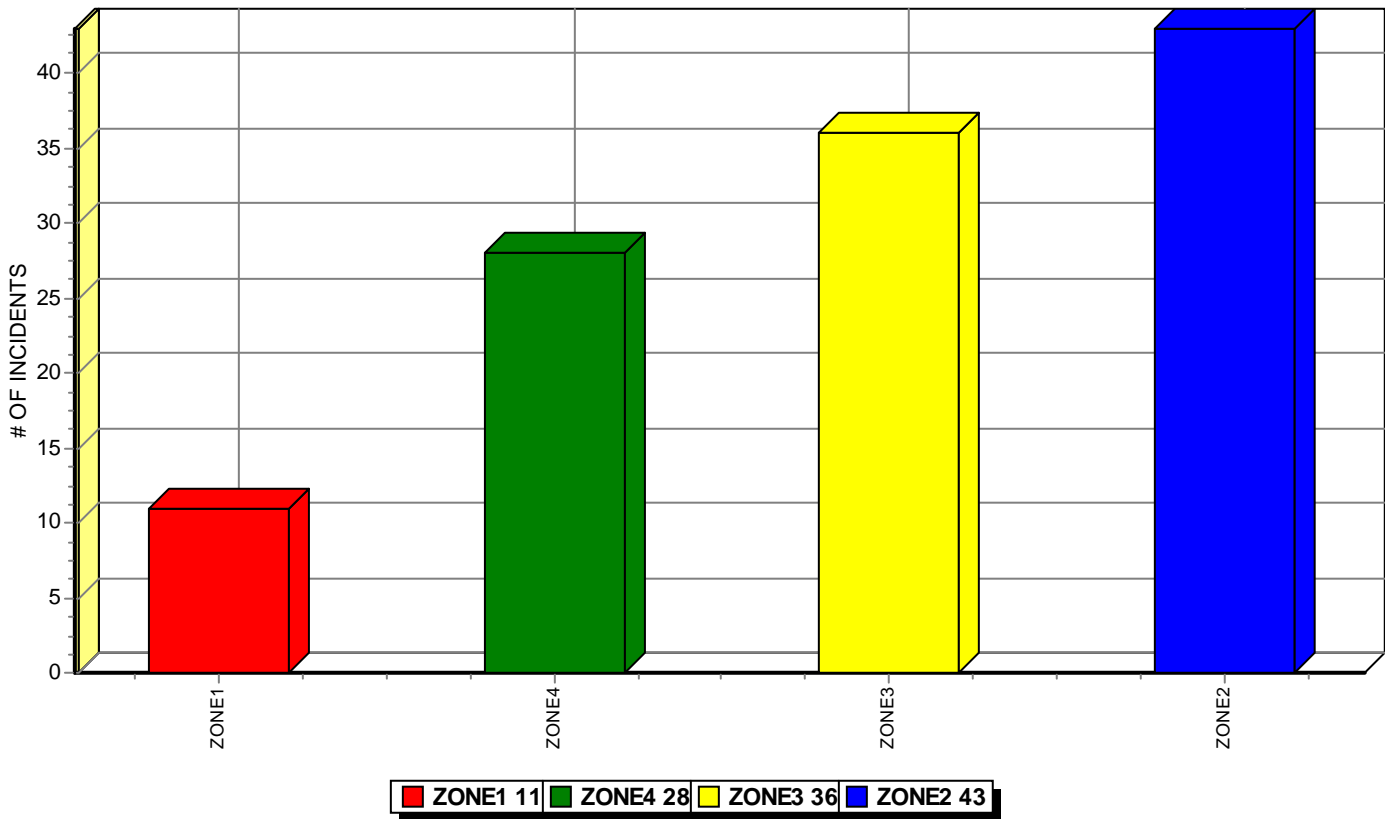

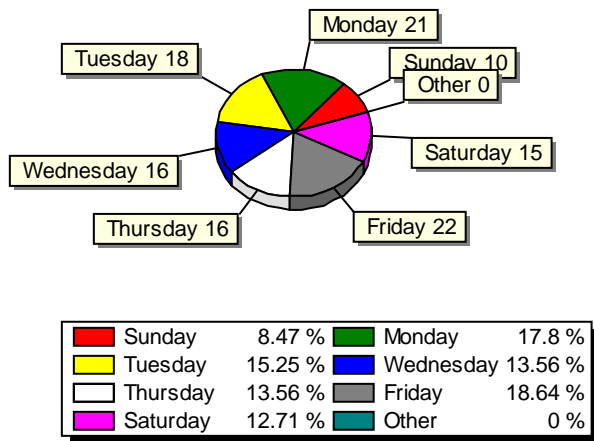

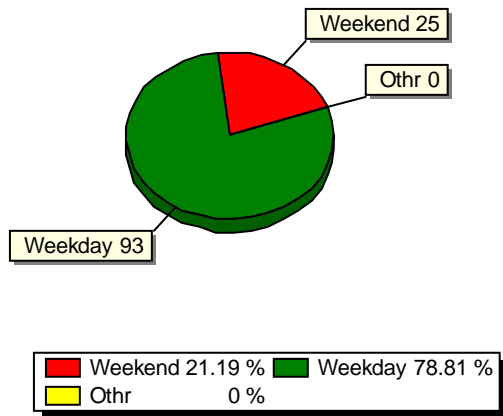
Incident Frequency by DISTRICT (Top 4 of 4 Shown) (Using DATE RECD)
