

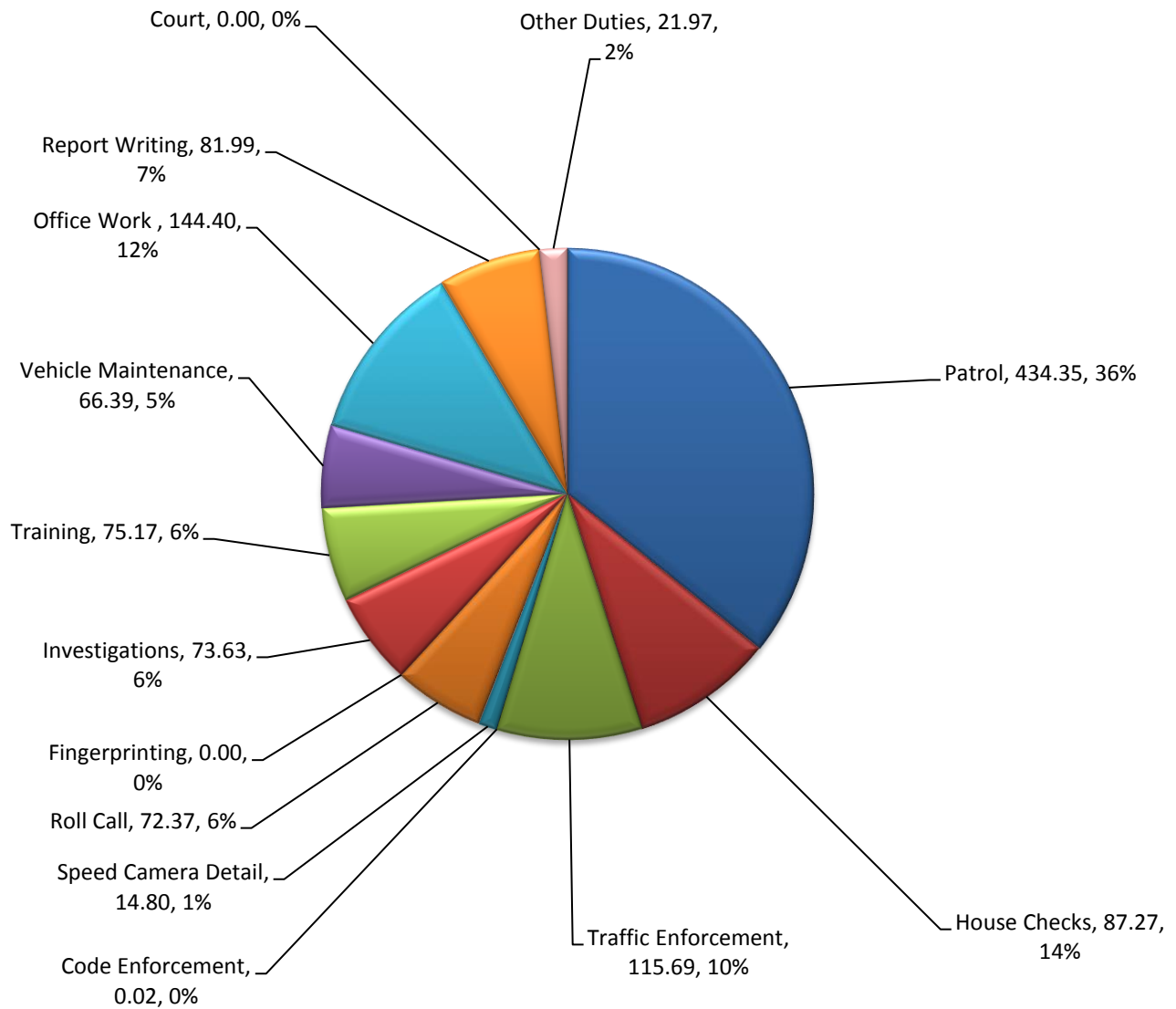

## Chevy Chase Village Police Department Officer Hours for June 2017 within Chevy Chase Village

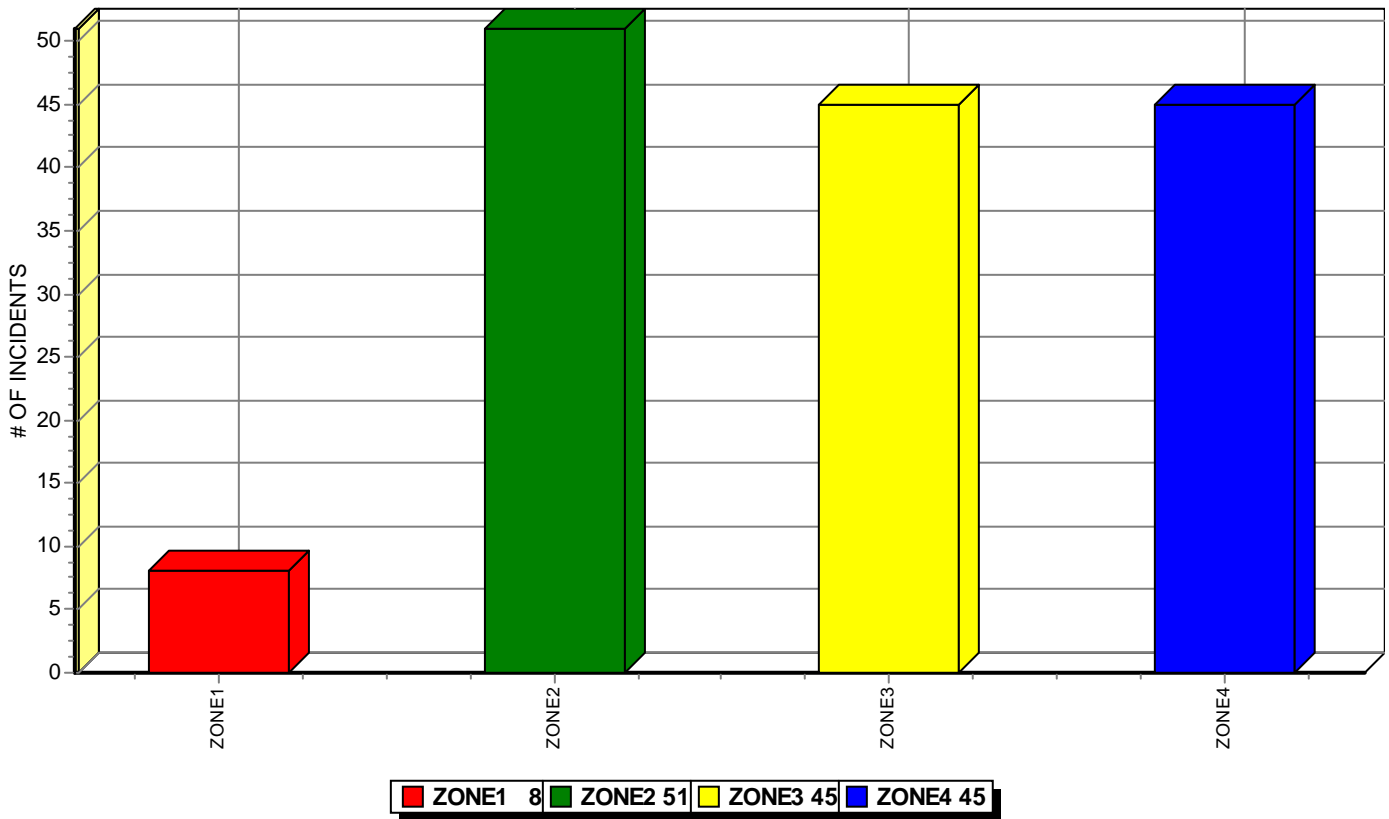

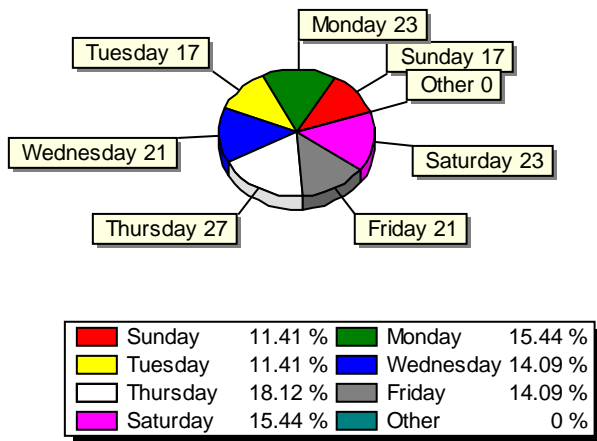

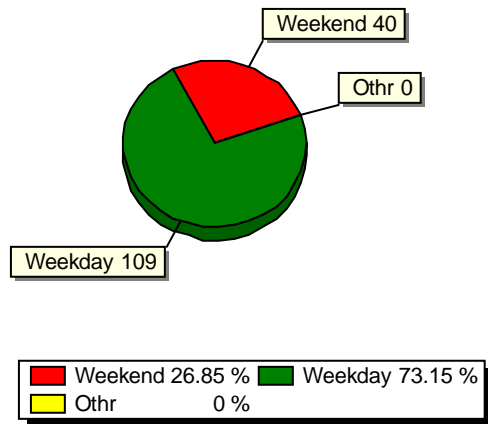
**Incident Frequency by DISTRICT (Top 4 of 4 Shown) (Using DATE RECD)**
